

J.D. students may **take a total of six credits, in no more than two classes, on a pass/fail basis** in their second and third years, if such an option is offered by the professor in a particular class. **Students who intend to use a class to satisfy the ABA upper-level writing requirement may not take the class on a pass/fail basis.**

Students who wish to exercise the pass/fail option must elect that option in EagleApps prior to the pass/fail deadline, which is published on the [Academic Calendar](#). All choices for pass/fail are final and cannot be changed once the deadline has passed.

LL.M students may take up to three credits, in no more than one class, on a pass/fail basis during the LL.M year. The United States Legal System, Law Practice I and Law Practice II may not be taken on a pass/fail basis.
