<p>EDUCATIONAL POLICY COUNCIL (EPC) This committee participates in the formulation of academic policy and planning decisions by providing assistance and consultation to the Dean on planning, developing, coordinating, and supervising curricula and programs. The Charter of the EPC describes its membership and process.</p>	<p>The EPC shall have nine members: five full time faculty , two students, and, ex officio, the Associate Dean of Faculty and the Dean. Four full time faculty shall be elected for a three-year term, one by each department. One faculty shall be appointed by the Dean for a two-or three-year term. Two students (one graduate and one undergraduate) shall be selected for a one-year term by their respective constituencies. The chair of the EPC shall be a faculty member elected by the members of EPC for a two-year term.
